

MATILDE #HeartofEurope PHOTO CONTEST PRIVACY POLICY

In accordance with EU Regulation No. 2016/679 –General Data Protection Regulation (GDPR) and with the national legislation, hereinafter referred to collectively as the "Applicable Law", this policy statement addresses the subject of privacy with regard to the processing of personal data of users of the online web services https://matilde-migration.eu/.

This policy is also in conformity with Recommendation n. 2/2001 related to the minimum requirements for online data collection in the European Union, adopted by the European Data Protection Authorities – Working Party of Article 29, Directive No. 95/46/EU on 17 May 2001.

Pursuant to legal provisions, MATILDE guarantees that the processing of personal data will be performed in consideration of fundamental rights and freedoms as well as the dignity of the data subject, and in accordance with the legislative provisions of the Applicable Law and the confidentiality clauses included therein. In particular, the processing of personal data will be carried out in accordance with the principles of lawfulness, fairness, transparency, accuracy, purpose and storage limitations, data minimisation, integrity and confidentiality.

Before providing any personal data or completing an electronic online form, MATILDE invites users to carefully read this Privacy Policy.

The content of this privacy policy may be amended or updated to conform to legal and regulatory obligations with respect to data protection, to allow for technological advances on the webpage that could impact the modalities of processing and to reflect organisational modifications that affect the privacy structure.

Precise data protection information about specific services or data processing procedures may be displayed on the corresponding webpages of this website or transmitted directly to the data user.



2. Types of Personal Data Subject to Processing

"Personal data" means any information relating to an identified or identifiable natural person (the "Data Subject). An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, mental, economic, cultural or social identity of that natural person. The personal data that may be processed includes browsing data, data provided voluntarily by the data subject and cookies.





By participating in the MATILDE #HeartofEurope Photo Contest, the Participant acknowledges that they have read and accepted this privacy statement and the terms and conditions outlined here.

Participants agree that personal data including, but not limited to, name, mailing address, phone number, and email address ("Personal Data") may be:

- collected, processed, stored and otherwise used by the Data Controller, or any party authorized by them for the purposes of communication activities of the MATILDE project related to photo contest, conducting and administering the Competition or the Prize(s).
- used by the Data Controller to verify a Participant's identity, e-mail address and telephone number in the event a Participant qualifies for any applicable Prizes as well as to deliver the applicable Competition Prize(s).
- used to fulfill additional terms of the Competition or to contact a Participant in response to any question submitted by such Participant.
- shared by the Data Controller or any party authorized to comply with the law or in the good faith belief that such action is necessary in order to conform to the requirements of law or comply with legal process served on Data Controller, and to protect and defend Data Controller's rights or property.
- Winners' entries and names may be published online in the official website of the MATILDE project (matilde-migration.eu).

Additionally, we kindly ask that The Participant note:

- Through the online registration form the Data Controller collects personal data (participant e-mail, name) and the IP address, website data, location, and browser generated information.
- For the purpose of displaying the photos (entries of participants who have registered and accepted to take part in the #HeartofEurope contest), on https://matilde-migration.eu/, Data Controller will collect registered participants' personal data: - Social media user name/ID, IP address, browser cookie, browser user agent, timestamp.
- Your personal data will remain in MATILDE website database until the results of the competition have been published and usefully exploited. Personal data will be deleted, at the latest, one (1) year after the last action in relation to the competition.
- The collected personal data and all information related to the evaluation/study will be erased by the Data Controller at the latest six months after the end of the contract.
- Participant has the rights listed below:
 - · Right of access
 - Right to rectification
 - Right to erasure
 - · Right to restriction of processing
 - Right to object
 - Right to data portability
- The participant may withdraw their consent to electronic communication, and to the delivery
 of documents, to the update of contact information, at any time by contacting the Data
 Controller as set forth in these Rules. The Data Controller will send the Participant a
 confirmation notice once we have processed the change request



- The Participant has the right to lodge a complaint with a supervisory authority, in particular in the Member State of his or her habitual residence, place of work or place of the alleged infringement of the GDPR.
- The Participant who requests that their details be deleted or who withdraws their consent during the course of the Competition accepts that this will automatically terminate their participation in the Competition, since they may not be included in the list of Participants without their details being recorded.
